The Department of Information & Public Relations, Himachal Pradesh, Shimla-2 invites sealed bids from eligible firms/ agencies for empanelment of agency/agencies with the department for designing and printing of flex of permanent and temporary hoardings, installation, repair and maintenance of Solar Backlit Unipolar Hoardings, installation, repair and maintenance of ordinary Permanent Hoardings, installation of temporary hoardings, change of flex of solar unipolar and ordinary permanent hoardings, printing and installation of flex banners, printing and installation of cut outs and roll up standees based on Policies, Programs, Schemes and Initiatives of the Government at different locations of Himachal Pradesh for a period of two years.

The tender form complete in all respect in plain sealed envelope superscribing thereon Tender for empanelment of agencies for designing, printing and installation of Hoardings must reach this office on or before 19-05-2023 up to 2 PM which will be opened on the same day at 3 PM in the presence of tenderer or his/her authorized representative.

The rates for above mentioned works be quoted by the interested firms in the tender form, which may be procured from the Directorate of Information & Public Relations, Shimla-2 on any working day during office hours on payment of Rs 500/- (non-refundable) in cash. The tender form can also be downloaded from the departmental website www.himachalpr.gov.in. In that case, the firm would be required to enclose DD for Rs. 500/- in favour of Director, Information & Public Relations, H.P, Shimla-2 towards the cost of tender form otherwise the application will not be considered.

The Director Information and Public Relations, HP reserves the right to reject any or all tenders without assigning any reason thereof.

Tender document

Scope of work

- 1. The Department of Information & Public Relations, Himachal Pradesh, Shimla-2 intends to empanel agency/agencies for designing and printing of flex of permanent and temporary hoardings, installation, repair and maintenance of Solar Backlit Unipolar Hoardings, installation, repair and maintenance of ordinary Permanent Hoardings, installation of temporary hoardings, change of flex of solar unipolar and ordinary permanent hoardings, printing and installation of flex banners, printing and installation of cut outs and roll up standees based on policies, programs, schemes and initiatives of the Government at different locations of Himachal Pradesh for a period of two years from the date of signing the contract agreement with the department. For this purpose sealed bids are invited from eligible agencies/ firms to furnish their details given in the Annexure 'A' and quote their rates in Annexure 'B' for empanelment with the department for execution of works as per requirement of the department.
- 2. The successful bidder shall be responsible for installation of permanent/temporary hoardings of the specifications given in **Annexure 'B'**, at different locations in the State of Himachal Pradesh according to the requirement of the department.
- 3. The list of selected locations shall be provided by the department from time to time along with work orders to be issued as per requirement of the department.
- 4. The empanelment of agency shall be made on L-1 basis for five different categories of items given in **Annexure 'B'** and the selected tenderer in each category shall be required to enter into contract agreement with the department at the rates finalised on L-1 basis for all the items in each category.
- 5. If the selected agency/ firm refuses to enter into agreement with in stipulated time, it's EMD shall be forfeited. If the selected agency/ firm fail to discharge the work assigned to it, it's EMD and Security Money shall be forfeited.
- 6. In the interest of timely disposal of urgent works, the department reserves the right to engage agencies/ firms rated as L-2, L-3 or so during tender process for the execution of the work at the rates finalised on L-1 basis subject to entering in a contract agreement with the department and deposition of Security money as prescribed.

Eligibility Conditions:

- 1. Applicant agencies/ firms should be registered with the Department of Industries, Himachal Pradesh/MSME (applicable for item nos. 2, 3A, 3B, 4 and 5). Documentary evidence to this effect will have to be submitted along with the bids.
- 2. Applicants should have an average annual turnover of Rs. 50,00,000 (Rs. Fifty Lakh Only) for last three financial years. Turnover details for the last three years will have to be submitted along with the form for Technical Bid and photocopy of P&L

- Account and Balance Sheet for last three years shall have to be submitted duly certified by the CA of the firm/agency.
- The tenderer must have his own flex printing unit in Himachal Pradesh which will be inspected by the team of officers nominated by DIPR (applicable for item nos. 2, 3A, 3B, 4 and 5).
- 4. Applicants should have a minimum of three years experience in the same field with government or private sector institutions. Relevant self attested certificates will have to be submitted along with the bids.

Terms and Conditions

- 1. The applicants will have to deposit a sample of all the materials specified in Annexure 'B' to be used in the hoardings. The samples should conform to the specifications provided by the department (applicable for item no. 1 and 2).
- 2. The applicant is required to attach tender document fee of Rs. 500/- (Five Hundred Only) (Non-refundable) through a bank draft duly pledged in favour of Director, Information and Public Relations, H.P., Shimla-2 along with tender. In the absence of deposition of required tender fee the applications shall not be considered for opening.
- 3. The applicant is required to attach earnest money of Rs. 1,00,000/- (refundable) through a bank draft duly pledged in favour of Director, Information and Public Relations, H.P., Shimla-2 along with tender. The earnest money of successful bidder will be retained by the department, which will be refunded after the expiry of the contract.
- 4. The Security amount @ Rs. 5 lakh will have to be deposited by the successful bidder in the form of Demand Draft of any nationalized bank duly pledged in the name of Director, Information and Public Relations Department payable at Shimla, at the time of entering into contract agreement with the department.
- 5. Interested firms/agencies shall be required to submit their bids in sealed envelope consisting of two separate sealed envelopes for Technical Bid and Financial Bid. The financial Bid of only those agencies shall be opened who qualifies the technical criteria.
- 6. Completed tender documents are to be sent (as per tender forms enclosed as Annexure "A" and "B") super subscribing thereon "Tender for empanelment of agency for the purpose of Printing & installation of Hoardings" and should reach this office on or before 19-05-2023 up to 2 PM, which will be opened on the same day at 3 PM in the presence of tenderers or their authorized representative.
- 7. The rate contract shall be applicable for two years extendable for one more year.

- 8. The agency/ firm should be able to execute work within 24 hours at Shimla and within 72 hours at any other location in the State in respect of item no. 2, 3A, 3B, 4 and 5 as per requirement of the department.
- 9. The designing, printing and installation of permanent and temporary Hoardings of the sizes other than as specified in the Annexure "B", the rates shall be considered on pro rata basis on the basis of the rates finalized in respect of item no. 1, 2, 3A and 3B of Annexure "B".
- 10. The rates quoted shall be inclusive of all taxes and FOR at any location in the State of H.P.
- 11. If the services provided by the successful agency/ firm are not as per the specifications, the payment of the bills submitted by the agency/firm will not be made and for any serious lapses or fraudulence on the part of agency/ firm, contract for installation of hoardings will be cancelled and security money pledged in the name of DIPR HP will be forfeited in favour of Government which may include blacklisting of the firm.
- 12. The publicity work of the department is of utmost importance and any delay in execution of work cannot be afforded. In case of any delay in execution of assigned work order, DIPR reserves the right to terminate the contract and to forfeit the earnest money and security money deposited with the department.
- 13. The selected agency/ firm will be bound to maintain all departmental hoardings in good conditions.
- 14. The permanent hoardings (unipole and ordinary) will be the sole property of Information and Public Relations Department, HP. However, repair and maintenance of permanent structures of hoardings will have to be carried out by the empanelled agency/ firm. The repairing of the structure in case of major damages due to natural causes etc. will be done by the agency/ firm on actual cost basis.
- 15. The shifting/ removal of permanent hoardings, if required, will also have to be done by the empanelled agency on actual cost basis. In such cases, the agency/ firm will have to produce an undertaking that they have not charged above the actual market rate.
- 16. The temporary hoardings shall be retained at the location for at least one month or as specified in the work order. Being property of the agency/ firm, these are to be maintained by the agency/ firm for the specified period. The agency/ firm will have to replace the flex the 50 percent cost of which will be borne by the Department.
- 17. No subletting will be authorised. The agency will be responsible for the execution of whole work itself.

- 18. It shall be the responsibility of empanelled agencies to remove flex of the permanent and temporary hoardings as per the instructions of the department as and when required.
- 19. The bill of each executed work should be submitted to this office within two months after the execution of work. The verification certificate and GPS tagged coloured photographs clicked by the agency at it's own cost in daylight should also be submitted alongwith the bill. The photographs of each hoarding should have one close shot and one long shot. The certificate and photographs should be duly verified by the District authorities.
- 20. DIPR HP reserves the right to accept or reject the tender without assigning any reason.
- 21. DIPR HP reserves the right to modify or change the terms and conditions of empanelment without assigning any notice.
